#### Preamble:

Ballary Rudrappa Education Society, Ballary Rudrappa Education Society's B.Ed College, Mtebennur P.O. Byadgi Taluk, 84-2 & 82/b/2, Byadgi Road, Haveri Disrict-581136, Karnataka has submitted application for offering B.Ed course on 27.08.2008. The recognition has been refused to the institution vide order dated 28.05.2009.

The institution prefferred an appeal and the Appellate Authority NCTE, New Delhi has confirmed the rejection order of SRC vide order dated 11.09.2009.

Aggrieved by the rejection order of the Appellate Authority, NCTE, New Delhi, the institution has filled W.P.No.66762/2009 in the Hon'ble High Court of Karnataka, Circuit Bench at Dharwad. The writ petition has been diposed of directing the petitioners to make an application for inspection to the NCTE within one week with requisite fees and was further pleased to direct the NCTE to inspect the institution within 6 weeks from today in accordance with law, without waiting for the certified copy.

In obediance to the court directions, the institution has submitted application along with requisite fee on 13.07.2010.

The SRC in its 194<sup>th</sup> meeting held on 21-22 July 2010 considered the matter and decided to call for documents/ clarification. Accordingly, a notice was issued to the Institution on 30.08.2010. The institution submitted the written representation on 13009.2010 along with duly filled Questionnaire.

The SRC in its 196<sup>th</sup> meeting held on 15-16 September 2010 considered the representation and decided to cause inspection. Accordingly, inspection was carried out on 20<sup>th</sup> October 2010. SRC in its 189<sup>th</sup> meeting held on 24-26 November 2010 considered the VT Report and decided to issue Showcause notice. Accordingly, showcause notice was issued to the institution on 03.01.2011. The institution has submitted its written representation on 13.01.2011. SRC in its 200<sup>th</sup> meeting held on 20-21 January 2011 considered the written representation and decided to issue letter of intent. Accordingly, Letter of Intent was issued to the institution on 27.01.2011.

The institution has submitted reply to Letter of Intent on 03.02.2011 and 11.02.2011 and the same was placed before SRC in its 201<sup>st</sup> meeeting held on 22-23 Februray 2011.

The SRC in its 200th meeting held on 20-21 January 2011 considered the reply of the instittution and decided to issue formal recognition.

Hence the order.

### ORDER

WHEREAS in terms of Section 14(1) of the NCTE Act, 1993 Ballary Rudrappa Education Society;s B.Ed College, Motebennur P.O, Byadgi Taluk, 84-2 & 28/b/2, Byadgi Road, Haveri Disrict-581136, Karnataka has submitted an application to the Southern Regional Committee of NCTE for grant of recognition Ballary Rudrappa Education Society's B.Ed College, Motebennur P.O, Byadgi Taluk, 84-2 & 28/b/2, Byadgi Road, Haveri Disrict-581136, Karnataka for conducting B.Ed course with an intake of 100 students on 29.05.2009.

- 2. AND WHEREAS on scrutiny of the application submitted by the institution, the documents attached therewith, the affidavit and the input received from the visiting team in the form of report and videography, institution fulfills the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the **B.Ed** Teacher Education programme such as instructional facilities, infrastructural facilities, library, accommodation, financial resources, laboratory etc. for running the programme and has appointed duly qualified teaching staff as per NCTE norms.

#### ORDER

WHEREAS, in exercise of the powers conferred by sub-section(2) of Section 32 of the National Council for Teacher Education Act, 1993(73 of 1993), and in supersession of the National Council for Teacher Education [Recognition Norms and Procedure] Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014 on

2.ANDWHEREAS, the institution, Ballary Rudrappa Education Society's B.Ed College, Motebennur Post, Byadgi Taluk, 84-2 & 28/b/2, Byadgi Road, Haveri District – 581136, Karnataka has by affidavit consented to come under New Regulations and sought for two basic units in B.Ed which require additional facilities.

- AND WHEREAS, it has been decided to permit the institution to have two basic units of 50 students each subject to the institution fulfilling following conditions namely,
  - The institution shall create additional facilities that include (a) additional built-up area,
     (b) additional infrastructure,
     (c) additional funds,
     (d) additional staff as per Regulations,
     2014 and inform Regional Committees with required documents by October 31, 2015.
- II. The applicant-institution for additional unit will be required to submit the required documents such as land documents, Encumbrance Certificate (EC), Land Use Certificate (LUC), Building Plan (BP) and the Approved Staff List in the specified proforma available on the website to the Regional Committee in proof of having provided additional facilities before October 31, 2015. Building Completion Certificate (BCC) may be given along with other documents if available, otherwise it can also be given to the Visiting team at the time of inspection.
- III. The Regional Committees shall arrange for verification of documents, inspection of these premises and check adherence to these conditions by 20 Feb, 2016. If it is found by the Regional Committee that the institution fails to comply with these requirements, the institutions shall not be permitted to admit students for the academic year 2016-2017
- 4. NOW THEREFORE, in the light of the above and in terms of Section 14(3) of NCTE Act and in accordance with the Regulations, 2014, the Southern Regional Committee, NCTE hereby grants recognition to Ballary Rudrappa Education Society's B.Ed College, Motebennur Post, Byadgi Taluk, 84-2 & 28/b/2, Byadgi Road, Haveri District 581136, Karnataka for conducting B.Ed programme of two years duration with an annual intake of 100 for two basic units of 50 students each from the academic session 2015-16 subject to fulfilment of the conditions mentioned herein before 31.10.2015
- Further, the recognition is subject to fulfilment of other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc, as applicable.

i) The affidavit with enclosure submitted along with application.

- j) The institution shall be free to post additional relevant information. if it so desires.
- k) Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

If the institution Contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and Orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the regional committee under the provisions of Section 17(1) of the NCTE Act.
